This has reference to your communication dated nil on the above mentioned subject. The proposal was considered as per the EIA Notification - 2006, by the State Level Expert Appraisal Committee, Maharashtra in its 11th & 22" meetings and decided to recommend the project for prior environmental clearance to SEIAA. Information submitted by you has been considered by State Level Environment Impact Assessment Authority in its 27th meeting held on 17th September, 2010.

It is noted that the proposal is for grant of Environmental Clearance for "Ganga Silicon Square", at Wakad, Pune by M/s. Shree Balaji Ventures. SEAC considered the project under Category 'B2' of EIA Notification 2006, and screening category is 8(a).

### Rain water Harvesting:

- Drive way all lights shall be on for 12 hrs only.
- Roof insulation shall be planned to conserve energy (commercial area)
- Solar based water heaters around 15% energy will be saved due to this.
- Routine passive solar architectural features shall be incorporated in building construction
- Variable voltage drivers for lifts

Green Belt Development: 6,095.24 sq. m. area will be provided for green belt. 235 Nos. of new trees shall be planted.

Traffic Management: parking area: 16,834 sq. m. 1,762 nos. for 2 wheeler and 658 nos. for 4 wheeler parking will be provided.

# Environmental Management Plan:

Construction Phase: Capital cost ₹71,01,000/-

Operation Phase: ₹2,44,350/-

- The proposal has been considered by SEIAA in its 27th meetings & decided to accord environmental clearance to the said project under the provisions of Environment Impact Assessment Notification, 2006 subject to implementation of the following terms and conditions :-
  - Project proponent shall ensure completion of STP, MSW disposal facility, green helt development prior to occupation of the buildings. No physical occupation or allotment will be given unless all above said environmental infrastructure is installed (i) and made functional. Prior certification from appropriate authority shall be obtained.
  - Local body should ensure that no occupation certificate will be issued prior to operation of STP/MSW site with due permission of MPCB. Physical possession should be given only after completion of environmental & other infrastructure for (ii) which development charges are being collected by local body.

- (iii) The height, Construction built up area of proposed construction shall be in accordance with the existing FSI/PAR norms of the urban local body & it should ensure the same along with survey number before approving layout plan & before according commencement certificate to proposed work. ULB should also ensure the zoning permissibility for the proposed project as per the approved development plan of the area.
- (iv) "Consent for Establishment" shall be obtained from Maharashtra Polkution Control Board under Air and Water Act and a copy shall be submitted to the Environment department before start of any construction work at the site.
- (v) All required sanitary and hygienic measures should be in place before starting construction activities and to be maintained throughout the construction phase.
- (vi) A First Aid Room will be provided in the project both during construction and operation of the project.
- (vii) Provision shall be made for the bousing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, mobile STP, safe drinking water, medical health care, crèche etc.
- (viii) Adequate drinking water and sanitary facilities should be provided for construction workers at the site. Provision should be made for mobile toilets. The safe disposal of wastewater and solid wastes generated during the construction phase should be ensured.
- (ix) Arrangement shall be made that waste water and storm water do not get mixed.
- (x) All the topsoil excavated during construction activities should be stored for use in horticulture / landscape development within the project site.
- (xi) Additional soil for leveling of the proposed site shall be generated within the sites (to the extent possible) so that natural drainage system of the area is protected and improved.
- (xii) Green Belt Development shall be carried out considering CPCB guidelines including selection of plant species and in consultation with the local DFO/ Agriculture Dept.
- (xiii) Disposal of muck during construction phase should not create any adverse effect on the neighboring communities and be disposed taking the necessary procautions for general safety and health aspects of people, only in approved sites with the approval of competent authority.
- (XiV) Soil and ground water samples will be tested to ascertain that there is no threat to ground water quality by leaching of heavy metals and other toxic contaminants.
- (XV) Construction spoils, including bituminous material and other hazardous materials must not be allowed to contaminate watercourses and the dampsites for such material must be accured so that they should not leach into the ground water.
- (xvi) Any hazardous waste generated during construction phase should be disposed off as per applicable rules and norms with necessary approvals of the Maharashtra Politation Control Board.
- (xvii) The diesel generator sets to be used during construction phase should be low sulphur diesel type and should conform to Environments (Protection) Rules prescribed for air and noise emission standards.
- (xviii) The diesel required for operating DG accs shall be stored in underground easies and if required, clearance from concern sufficient pitall be taken.
- (xix) Ychicles hired for bringing construction material to the size should be in good condition and should have a pollution check certificate and should conform to applicable air and noise emission standards and should be operated only during non-peak hours.
- (xx) Ambient noise levels should conform to residential standards both during day and night. Incremental pollution loads on the ambient air and noise quality should be closely monitored during construction phase. Adequate measures should be made to

- reduce ambient air and noise level during construction phase, so as to conform to the stipulated standards by CPCB/MPCB.
- (xxi) Fly ash should be used as bailding material in the construction as per the provisions of Fly Ash Notification of September 1999 and amended as on 27th August, 2003. (The above condition is applicable only if the project site is located within the 100Km of Thermal Power Stations).
- (xxli) Ready mixed concrete must be used in building construction.
- (xxiii) The approval of competent authority shall be obtained for structural safety of the buildings due to any possible earthquake, adequacy of fire lighting equipments etc. as per National Building Code including measures from lighting.
- (xxiv) Storm water control and its re-use as per CGWB and BIS standards for various applications.
- (xxv) Water demand during construction should be reduced by use of pre-mixed concrete, curing agents and other best practices referred.
- (xxvi) The ground water level and its quality should be monitored regularly in consultation with Ground Water Authority.
- (xxvii) The installation of the Sewage Treatment Plant (STP) should be certified by an independent expert and a report in this regard should be submitted to the Ministry before the project is commissioned for operation. Treated effluent emanating from STP shall be recycled/refused to the maximum extent possible. Treatment of 100% gray water by decentralized treatment should be done. Discharge of unused treated affluent shall conform to the norms and standards of the Maharashtra Pollution Control Board. Necessary measures should be made to mittigate the odour problem from STP.
- (xxviii)Project proponent shall ensure completion of STP, MSW disposal facility prior to occupation of the buildings and should obtain completion certification for these systems/aspects from MPCB.
- (xxix) Local body should ensure that no occupation certification is issued prior to operation of STP/MSW size etc. with due permission of MPCB.
- (xxx) Pennission to draw ground water shall be obtained from the compenent Authority prior to construction/operation of the project.
- (xxxi) Separation of gray and black water should be done by the use of dust phembing line for separation of gray and black water.
- (xxxii) Fixtures for showers, toilet flushing and drinking should be of low flow either by use of aerators or pressure reducing devices or sensor based control.
- (xxxiii) The solid waste generated should be properly collected and segregated. Wet garbage should be composited and dry/inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material.
- (xxxiv) Use of glass may be reduced up to 40% to reduce the electricity consumption and load on nirconditioning. If necessary, use high quality double glass with special reflective coating in windows.
- (xxxv) Reof should meet presuriptive requirement as per Energy Conservation Building
  Code by using appropriate thermal insulation material to fulfill requirement
- (seevi) Energy conservation measures like installation of Chie /TYLe for the lighting the areas outside the building should be integral part of the project design and should be in place before project commissioning. Use CFLs and TFLs should be properly collected and disposed officert for recycling as per the provailing guidelines/rules of the constant authority to avoid mercury contamination that of solar panels may be done to the extent possible like installing solar street lights, common solar water heaters system. Project proponent should install, after checking feasibility, solar plus hybrid non conventional energy source as source of energy.

(xxxvii) Diesel power generating sets proposed as source of back up power for elevators and common area illumination during operation phase should be of enclosed type and conform to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Use low sulphur diesel. The location of the DG sets may be decided with in consultation with Maharashtra Pollution Control Board.

(xxxviii) Noise should be controlled to ensure that it does not exceed the prescribed standards. During nighttime the noise levels measured at the boundary of the building shall be restricted to the permissible levels to comply with the prevalent regulations.

(xxxix)Traffic congestion near the entry and exit points from the roads adjoining the proposed project site must be avoided. Parking should be fully internalized and no public space should be utilized.

(xl) Opaque wall should meet prescriptive requirement as per Energy Conservation Building Code, which is proposed to be mandatory for all air-conditioned spaces while it is aspirational for non-air-conditioned spaces by use of appropriate thermal insulation material to fulfill requirement

(xli) The building should have adequate distance between them to allow movement of

fresh air and passage of natural light, air and ventilation

(xlii) Regular supervision of the above and other measures for monitoring should be in place all through the construction phase, so as to avoid disturbance to the surroundings.

(xliii) Under the provisions of Environment (Protection) Act, 1986, legal action shall be initiated against the project proponent if it was found that construction of the project

has been started without obtaining environmental clearance.

(xliv) Six monthly monitoring reports should be submitted to the Department and MPCB.

(xlv) A complete set of all the documents submitted to Department should be forwarded to the MPCB

(xivi) In the case of any change(s) in the scope of the project, the project would require a fresh appraisal by this Department.

(xivii) No land development / construction work preliminary or otherwise relating to the project shall be taken up without obtaining due clearance from respective authorities.

(xlviii) A separate environment management cell with qualified staff shall be set up for implementation of the stipulated environmental safeguards.

(xlix) Separate funds shall be allocated for implementation of environmental protection measures/EMP along with item-wise breaks-up. These cost shall be included as part of the project cost. The funds earmarked for the environment protection measures shall not be diverted for other purposes and year-wise expenditure should reported to the MPCB & this department.

(I) The project management shall advertise at least in two local newspapers widely circulated in the region around the project, one of which shall be in the marathl language of the local concerned within seven days of issue of this letter, informing that the project has been accorded environmental clearance and copies of clearance letter are available with the Maharashtra Pollution Control Board and may also be seen at Website at <a href="http://envis.maharashtra.gov.in">http://envis.maharashtra.gov.in</a>.

(ii) Project management should submit half yearly compliance reports in respect of the stipulated prior environment clearance terms and conditions in hard & soft copies to the MPCB & this department, on 1<sup>st</sup> June & 1<sup>st</sup> December of each calendar year.

(iii) A copy of the clearance letter shall be sent by proponent to the concerned Municipal Corporation and the local NGO, if any, from whom suggestions/representations, if any, were received while processing the proposal. The clearance letter shall also be put on the website of the Company by the proponent.

(liii) The proponent shall upload the status of compliance of the stipulated 6C conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MoEF, the respective Zonal Office of CPUB and the SPCB. The criteria pollutant levels namely; SPM, RSPM, SO<sub>2</sub>, NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the project shall be monitored and displayed at a convenient location near the main gate of the company in the public domain.

(liv) The project proponent shall also submit six monthly reports on the status of compliance of the stipulated EC conditions including results of monitored data (both in hard conies as well as by e-mail) to the respective Regional Office of MoEF, the

respective Zonal Office of CPCB and the SPCB.

(iv) The environmental statement for each financial year ending 31st March in Form-V as is mandated to be submitted by the project proponent to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as animaled subsequently, shall also be put on the website of the company along with the status of compliance of EC conditions and shall also be sent to the respective Regional Offices of MoEF by e-mail.

(Ivi) The environmental elearance is being issued without project to the court case pending in the court of law and it does not mean that project proponent has not violated any environmental laws in the past and whatever decision of the Hon'ble court will be binding on the project proponent. Hence this clearance does not give

immunity to the project proponent in the case filed against lum.

4. Project proponent should submit exactly same documents for approval of building plans to the concern authority as per the documents arbitited to the SELVA for prior Environmental Common

- 9. In case of any deviation or alteration in the project proposed from those submitted to this department for elements, a nesh reference should be made in the department to assess the adequacy of the elementor(s), imposed and to incorporate additional environmental protection measures equival, if any.
- 10. The above stipu clique would be enforced among others under the Water direvention and Control of Pollution ) Act. 1974, the Air (Prevention and Control of Pollution ) Act. 1981, the Environment (Protection) Act, 1986 and rules there under, Hazzartous Wastes.
